

Long range planning began in earnest starting in 2011, engaging multiple committees and church members. Through this process we have reaffirmed our commitment to our identity as a "neighborhood church" that is here to welcome and serve our members and surrounding community in Christ's love. The demographics in and around St. Paul continue to change, and over 40 new active members were welcomed into our community in 2018 alone. As we continue to grow, we need to consider new approaches to meet the needs of our community in the future. Our current building and campus layout can make it difficult to carry out the ministries important to us due to space, safety and accessibility limitations.

Safety and Accessibility:


- New and reconfigured parking lots •

Potential Building Project Funding

The proposed building renovation plans and site work are conservatively estimated to cost \$3 to \$3.5 million. This is a very rough estimate for all of the work proposed, which will guide us over the course of the coming years. Total work and associated costs of this initial phase may be significantly altered and will be prioritized according to need, efficiency and impact on overall ministry. With good stewardship practices, we set aside \$140,000 from our Capital Projects Fund for this building project. We are planning on conducting a capital campaign in the coming months. Raising the project funds would be a worthy challenge for a congregation our size, stretching all of us in our generosity. We are prepared to enlist the help of The James Company, a stewardship consulting firm, to assist us. The James Company has successfully helped many ELCA congregations with their capital campaigns.

By spring 2020, after the three-year capital campaign pledges are received, we will have a better understanding of the total funds we can expect from our members. We would also welcome offers of in-kind services and construction skills to help reduce the cost of our building project. The response of our members to the capital campaign will be a significant factor in determining how much of the proposed concept can be accomplished, and in what phases the work will be divided. We are also open to the possibility of borrowing project funds, but wish to keep this to a minimum. It is possible that we could begin our building projects as early as summer 2020.

Property Acquisition Funding

We recently acquired property at 536 S. Cornell, adjacent to our current parsonage. This purchase provided increased flexibility for our site planning as reflected in the designs included in this brochure. The purchase price of \$220,000 was primarily funded by our cash reserves. Our goal is to fund the building project and rebuild our cash reserves through our proposed capital campaign.

Potential Ministry Funding

As we grow, we anticipate opportunities to expand our ministries in creative and exciting ways. By tithing 10% of our capital campaign gifts for our ministries, we can ensure we have the seed funding needed to staff and kickstart new opportunities to grow, care, give and share in Jesus' name.
